ICARE provided direct ophthalmic services to over 100,000 people across 19 districts of the country. Among these over 14,000 received surgical intervention for cataract and other conditions either free of cost or at a subsidized rate.

ICARE has a clear vision to eradicate avoidable blindness in India, as a mean to empower those already underprivileged. Last financial year (2015-16), ICARE performed approximately 22,000 surgeries, one of the highest in North India, out of which 64% was for charity.

I would also like to thank our donors, project partners for their support and staff for their commitment and dedication to furthering ICARE's mission. Last but not the least, our Board of Trustees for their guidance and unwavering faith in us. ICARE is blessed to have a team of dedicated volunteers spends their valuable time to help us grow. 



The Past and the Present For the past 22 years, since its inception in 1993, ICARE Eye Hospital & postgraduate Institute an unit of Ishwar Charitable Trust has served eye care needs of many a million. While remaining committed to eradicating avoidable blindness, the very core of it's being, in the last few years, the organization has been following a parallel charter to evolve in to a Tertiary Eye Institute. It has chosen to focus on Comprehensive Eye care, Quality consciousness, Community Impact, Research and training and above all, Transparency as the building blocks for the future.

HIGHLIGHTS FROM THE YEAR 2015-16

- The Institutional network screened 271971 patients across its primary, secondary and tertiary facilities.
- 21567 Sight restoring surgeries were performed.
- 13897 of above surgeries were done free or partially subsidized.
- The Eye Banking initiative continued to grow with 97 corneal tissues retrieved by the eye banking team through HCRP (Hospital based Cornea Retrieval Programme) and direct tissue donations.







